Caller ID "Spoofing"
Caller ID "Spoofing" is a term used to describe disreputable parties who deliberately falsify the telephone number relayed as the Caller ID number to disguise the identity and originator of the call. If you think you are being "spoofed", hang up and call the company/person the call came from to verify the call is legitimate. Congress is considering new laws that would make this practice a crime and permit law enforcement authorities to take action against spoofer.

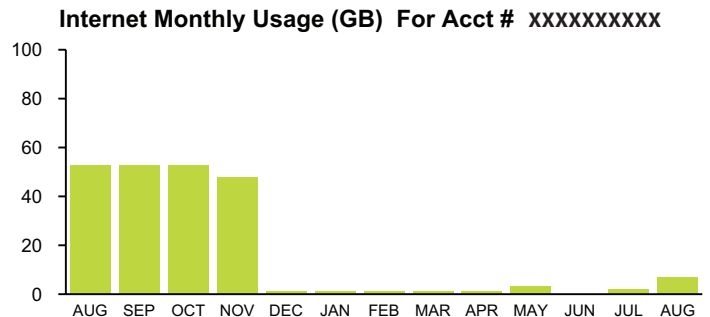
